INSIEL S.p.A. is the **Data Processor** of Personal Data (Art. 28 of the GDPR) connected to the provision of services that it provides to the Bodies and Agencies of the autonomous Region of Friuli Venezia Giulia as part of the Regional Integrated Information System (S.I.I.R.) pursuant to regional law 14 July 2011, n. 9.

Purpose, legal basis and compulsoriness of processing: data provided for the obligations required by the activities related to the management of the procedure for awarding public contracts, the stipulation of contracts/orders for supplies/services/professional services, the subsequent management of administrative, accounting and tax obligations, are processed in accordance with the provisions in force for the purposes of the procedure for which they were requested and are used exclusively for this purpose and for the institutional purposes of the Regional Agency for Rural Development - ERSA.

Categories of Personal Data: the data processed concern data of a personal nature, such as personal data, data that allow indirect identification, residence/domicile, telephone numbers, email accounts, bank account number.

Recipients of Personal Data: the data may be communicated to other public administrations and to other parties requesting access to documents of related administrative procedures, in accordance with the procedures and within the limits of the provisions of the relevant legislation.

Duration of Personal Data storage: personal data will be kept for the time strictly necessary to achieve the purposes for which they were collected, without prejudice to the provisions on the duration of publication for transparency and on storage and retention, also IT, of documents. The storage of personal data is also carried out in accordance with the regional legislation referred to in the Decree of the President of the Regional Council 4 October 1999, n. 0309/ Pres.

The interested party has the right, within the limits provided by Chapter III of the GDPR, to request access to his personal data, rectification, cancellation and restriction thereof, has the right to object to the processing and has the right to submit a complaint to the Data Protection Supervisor.

The interested party is obliged to provide the personal data requested, without which ERSa will not be able to process the request.
